

**AN ORDINANCE ENACTING AND ADOPTING A SUPPLEMENT
TO THE CODE OF ORDINANCES FOR THE
TOWN OF BISCOE, NORTH CAROLINA**

WHEREAS, American Legal Publishing Corporation of Cincinnati, Ohio, has completed S-3 supplement to the Code of Ordinances of the Town of Biscoe, which supplement contains all ordinances of a general and permanent nature enacted since the adoption of the Code of Ordinances of the Town of Biscoe; and

WHEREAS, American Legal Publishing Corporation has recommended the revision or addition of certain sections of the Code of Ordinances which are based on or make reference to sections of the North Carolina code, in addition to resolutions and ordinances enacted by the Board of Commissioners; and

WHEREAS, it is the intent of the Board of Commissioners to accept these updated sections in accordance with the changes of the law of the State of North Carolina and resolutions and ordinances duly adopted by the Board of Commissioners; and

WHEREAS, it is necessary to provide for the usual daily operation of the Town of Biscoe and for the immediate preservation of the public peace, health, safety, and general welfare of the Town of Biscoe that this ordinance take effect at an early date;

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE TOWN OF BISCOE, NORTH CAROLINA;

Section 1. That the S-3 supplement to the Code of Ordinances of the Town of Biscoe as submitted by American Legal Publishing Corporation of Cincinnati, Ohio, and as attached hereto, be and the same is hereby adopted by reference as if set out in its entirety.

Section 2. Such supplement shall be deemed published as of the day of its adoption and approval by the Board of Commissioners and the Clerk to the Board of Commissioners is hereby authorized and ordered to insert such supplement into the copy of the Code of Ordinances kept on file in the Office of the Clerk to the Board.
