Fiscal Year 2021-2022 Budget Approved By Biscoe Town Board

The 2021-2022 Budget has been approved by the Town Commissioners. There are no changes in fees. Water and sewer rates will remain the same, and there is no property tax increase. The Town has maintained the same tax rate of \$0.58 per \$100 since 2013. The budget as a whole is \$3,115,069, this is less than the current year and is the lowest it's been in 3 years.

One of the priorities of the Town Commissioners is to increase the financial health of the Town by adding to the Fund Balance, the budget has been prepared with this goal in mind. Overall, debt has decreased, and operations will continue to offer all current services.

The Town will continue contracting with State Code Enforcement to help keep our community clean. The Police Department will purchase two used patrol vehicles, and the fire department members meeting certain criteria will be reimbursed \$5 per call. There are some system repairs scheduled for the Water/Sewer department, and the recreation budget continues to fund recreation programs, including the senior program.

I'd like to commend the staff and Commissioners on their involvement and support during this budget season and for continuing to make the best financial decisions for the Town. The complete document can be found on the Town website.

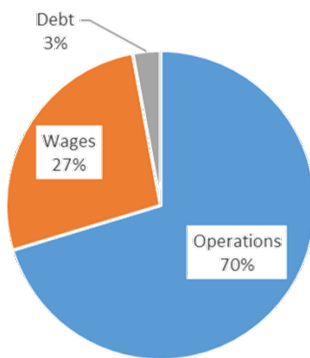

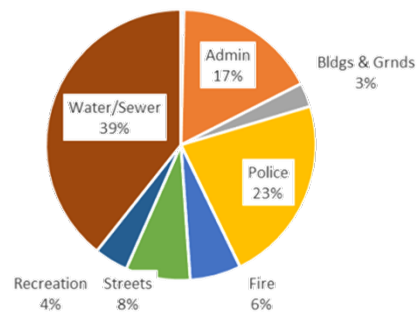

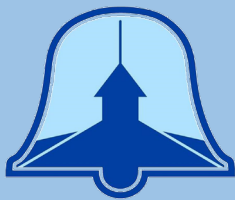


Total Budget Breakdown

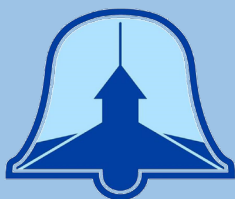

CARES ACT FUNDING REPORT



In August of 2021, an email was received from Montgomery County Finance stating The State has made available the second round of CARES Act funding. Counties were asked to administer these funds on behalf of the Towns. The total portion for the Town of Biscoe was \$66,565.72. A full report of

these expenditures was sent to the County Finance for reimbursement. The reimbursement is expected the week of June 14, 2021. The chart below is a summary of how Biscoe’s portion of the CARES Acting funding was spent:

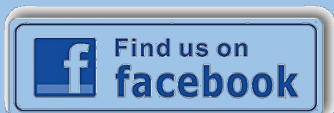

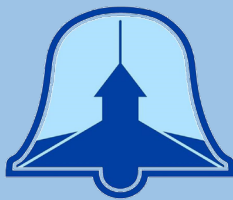

\$29,915.02 Grant Awarded to Biscoe Fire Department

Department of Insurance Sends Award Check for New Equipment

RALEIGH - Insurance Commissioner and State Fire Marshal Mike Causey announced that the Biscoe Fire Department was awarded a \$29,915.02 grant through the 2021 Volunteer Fire Department Fund from the State of North Carolina.

The check will be mailed to Fire Chief Sammy Ray Stewart to be used by the Department to purchase needed equipment. The equipment is purchased using matching funds and must be approved by the Department of Insurance Office of State Fire Marshal.

"Fire and rescue organizations protect our communities large and small across North Carolina, but sometimes their budgets don't grow with their responsibilities," Commissioner Causey said. "Our emergency service personnel should be supported with the best equipment and supplies needed to do their jobs correctly and safely."

"I know the Biscoe Fire Department, will use this money to serve their community even better," Causey added. "Thank you, Chief Sammy Ray Stewart, for all of your hard work and thanks to your dedicated staff."

Biscoe Fire Department has received a total of \$366,751.04 from the Volunteer Fire Department Fund in the past 33 years since the program began. The General Assembly created the Volunteer Fire Department Fund in 1988 to help volunteer units raise money for equipment and supplies. The grant funds must be matched dollar-for-dollar for an amount approved up to \$30,000, unless the department receives less than \$50,000 per year from municipal and county funding, in which case the applicant shall match \$1 for each \$3 of grant funds up to \$30,000. Since the program's inception, the Department of Insurance has distributed \$151,203,110.83 to volunteer fire departments across the state.

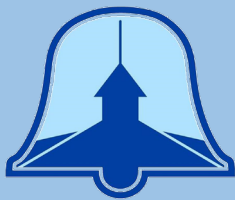

TOWN OF BISCOE, NORTH CAROLINA Annual Wastewater Treatment Plant and Sewage Collection Report for January 1, 2020 through December 31, 2020

The General Assembly of the State of North Carolina has passed House Bill 1160 requiring that all entities that own or operate wastewater collection and treatments systems make an annual report available to their customers. This report must include information as to how well the system operated, what violations occurred, and other information. This report is produced in compliance with these requirements.

The Town of Biscoe Public Utilities Department operates one wastewater treatment plant and a sewage collection system that collects and transports the sewage to this plant. The following are the professionals designated by the state as the "Operators in Responsible Charge" (ORC) of the respective systems and permits for the systems:

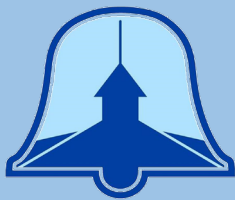

El Departamento de Servicios Públicos de la Ciudad de Biscoe opera una planta de tratamiento de aguas residuales y un sistema de recolección de aguas residuales que recolecta y transporta las aguas residuales a esta planta. 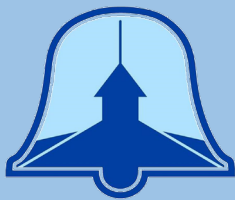

ANNUAL REPORT

The sewage collection system of the Town of Biscoe has approximately 980 connections that serve residential, commercial, and industrial customers. There are approximately 27 ¾ miles of sewer line in the collection system with sizes that vary from 6 to 12 inches in diameter. There are ten sewage lift pump stations in the collection system located in areas where gravity flow cannot be achieved. The purpose of the sewage collection system is to transport the wastewater generated by the Town customers to the wastewater treatment facility.

The town did NOT experience overflows in the year 2020

The Town of Biscoe has a wastewater treatment facility with a rated capacity of 600 thousand gallons per day. This was reduced to 500 thousand gallons per day during the year 2005. The plant is called an open aeration style plant and was built in the mid 1970's. All of the treated wastewater produced by this facility is discharged to Hickory Branch. The bio-solids or dried sludge generated by this facility is disposed of in the county landfill.

During the reporting period (2020) the Town of Biscoe treated approximately 116.30 million gallons of wastewater.

The town did NOT experience a Bypass/Upset in 2020

The wastewater treatment facility operates under what is called an NPDES permit, or National Pollutant Discharge System permit. This permit includes monitoring requirements and discharge limits, some of which vary with seasons and have different maximums for daily values, weekly averages, and monthly averages. Some limits protect streams from oxygen depletion, such as biochemical oxygen demand (BOD) and ammonia-nitrogen. Some limits are to protect aquatic life in the receiving stream, such as metals and other constituents. The permit can be viewed at our Municipal Building in the Superintendent of Public Utilities office.

REPORTE ANNUAL

El sistema de recolección de aguas residuales de la ciudad de Biscoe tiene aproximadamente 980 conexiones que sirven a clientes residenciales, comerciales e industriales. Hay aproximadamente 27 ¾ millas de línea de alcantarillado en el sistema de recolección con tamaños que varían de 6 a 12 pulgadas de diámetro. Hay diez estaciones de bombeo de aguas residuales en el sistema de recolección ubicadas en áreas donde no se puede lograr el flujo por gravedad. El propósito del sistema de recolección de aguas residuales es transportar las aguas residuales generadas por los clientes de la Ciudad a la planta de tratamiento de aguas residuales.

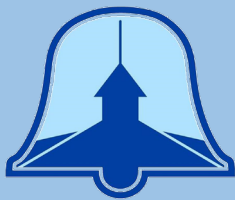
La ciudad NO experimentó desbordes en el año 2020

La ciudad de Biscoe tiene una planta de tratamiento de aguas residuales con una capacidad nominal de 600 mil galones por día. Esto se redujo a 500 mil galones por día durante el año 2005. La planta se llama planta de aireación abierta y se construyó a mediados de la década de 1970. Todas las aguas residuales tratadas producidas por esta instalación se descargan en Hickory Branch. Los biosólidos o lodos secos generados por esta instalación se eliminan en el vertedero del condado.

Durante el período del informe (2020), la ciudad de Biscoe trató aproximadamente 116.30 millones de galones de aguas residuales.

La ciudad NO experimentó un Bypass / Upset en 2020

La instalación de tratamiento de aguas residuales opera bajo lo que se llama un permiso NPDES o permiso del Sistema Nacional de Descarga de Contaminantes. Este permiso incluye requisitos de monitoreo y límites de descarga, algunos de los cuales varían con las estaciones y tienen diferentes máximos para valores diarios, promedios semanales y promedios mensuales. Algunos límites protegen los arroyos del agotamiento de oxígeno, como la demanda bioquímica de oxígeno (DBO) y el nitrógeno amoniacal. Algunos límites son para proteger la vida acuática en la corriente receptora, como metales y otros componentes. El permiso se puede ver en nuestro Edificio Municipal en la oficina del Superintendente de Servicios Públicos.



SOLID WASTE ORDINANCE -- ARTICLE II

Section 1: Garbage: Garbage taken to mean the organic waste matter, both animal and vegetable from houses comprising chiefly of waste food and not including liquid that may be drained into the sewer. Garbage also includes tin cans, glass containers, bottles, paper, and boxes. Recyclables should be placed in proper receptacles as provided.

Section 2: Rubbish: Rubbish shall be taken to include floor sweepings, old boots, and shoes, discarded clothing, cardboard boxes and all such waste materials that ordinarily collect from a home or business. Rubbish must be placed in trash can for Monday's pick-up.

Section 3: Debris: Debris shall be taken to mean tree limbs, brush, leaves, etc.

Section 3-A: Debris: The town will collect appliances and household furnishings. With the exception of any electronics. Example: TV's, computers, DVD players, microwaves, etc. The town will also not collect any construction or demolition material or remodeling material of any kind. Including: carpet, linoleum, sinks and toilets, cabinets, boards, plywood, wire, landscaping timbers, cardboard or cardboard boxes, tires, and batteries.

Section 4: It shall be the duty of every person owning, managing, operating, renting, occupying any dwelling, building or other place where garbage or rubbish accumulates or is produced to provide receptacles for such garbage or rubbish placed for collection by the garbage service. The following rules and regulations shall be observed.

Section 5: Residential receptacles shall be provided by the Town, which are purchased from Republic Services. Covers shall be kept on the receptacles at all times, except when being filled or emptied. Receptacles shall not have more than 32-gallon capacity each or less than 20-gallon capacity. Owners shall supply a sufficient number of such receptacles to hold the quantity of garbage or rubbish accumulated. All receptacles at all times must be so constructed and maintained, and so covered as to prevent the entrance of flies. Plastic garbage cans may be used, but owners are responsible for cleanup in case of ruptured bags. The Town of Biscoe will provide one receptacle per household. If an extra receptacle is needed, citizens may contact Town Hall at 428-4112 to request an extra receptacle. The monthly cost will be added to each month's utility bill.

Section 6: It is the duty of owners or occupants to set containers at curb side on designated pick-up days. It is the responsibility of the homeowner or renter to replace any lost or stolen receptacle.

Section 7: It shall be unlawful for any person to burn any matter in garbage or rubbish receptacles or bulk containers. No liquid or semi-liquid matter will be collected by the town, nor should such matter be put in containers for removal by the garbage collector.

Section 8: It shall be the intention of the Town of Biscoe to provide collection service for garbage and rubbish to every residence in the Town; however, weeks in which holidays are observed by collectors, collection service may be once a week.

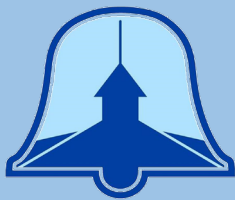
Section 9: Debris collection will be on a once-a-week schedule provided however that on weeks with certain holidays, or any town emergency that may occur no pick-up may be provided.

Section 10: All tree limbs, trunks, etc., shall be cut in lengths no greater than 6 ft. and placed neatly in a stack facing in the same direction as the road and free of all other debris and rubbish. No one piece to weigh over fifty (50) pounds. Pine straw and leaves will be collected when placed in neat rows next to the curbside away from obstacles such as trees, mailboxes, signs, and fire hydrants. Each pile should be free of limbs, rubbish, and all other debris. If leaf rows do not meet all requirements, they will not be collected.

Section 11: All large accumulations from lot clearings, tree removal or large quantities of tree and limb trimmings, building or home construction or repair shall be removed by contractor, homeowner or paid individual.

Section 12: It shall be unlawful for any person to throw, deposit in, sweep on, or rake into any street, sidewalk or gutter any leaves, trash, filth, rubbish, broken glass, tin cans, fruit peelings, refuse, ashes, wasted or loose paper. Such materials shall be accumulated as specified in this ordinance and placed in their respective places or proper receptacles as provided in this ordinance.

Section 13: Any person violating the provisions of this ordinance shall be guilty of this misdemeanor and shall be punished by a fine not to exceed one hundred fifty dollars (\$150.00) or by imprisonment for a term not exceeding thirty (30) days. Use Your Sewer System Wisely

We can help prevent most sewer back-ups and overflows with a progressive preventive maintenance program.

Sewer back-ups and overflows are often caused by improper materials such as fats, oils and grease being flushed into the sewer system. Fats, oils, and grease are lighter than water and tend to accumulate at the top and side of sewer pipes building up until a blockage occurs.

Sanitary sewer systems are designed to handle three things: used water, human body waste, and toilet paper. Some simple things to prevent blockages and save money are shown below.



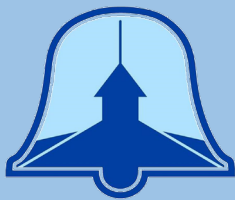
PLEASE dispose of your **Fats Oil & Grease** the right way and prevent sewer lines from overflowing.

PLEASE DO NOT

- Pour oil and grease down drains
- Wash fryers/griddles/pots/pans and plates with water until oil and grease are removed
- Use hot water to rinse grease off surfaces
- Put food scraps down drains

PLEASE

- Put oil and grease in collection containers
- Remove oil and grease from kitchen utensils, equipment, and food preparation areas with scrapers/towels/brooms
- Keep grease out of wash water
- Place food scraps in collection containers



ORDENANZA DE RESIDUOS SOLIDOS - ARTÍCULO II

Sección 1: Basura: Basura entendida como la materia de desecho orgánica, tanto animal como vegetal de las casas, que comprende principalmente desechos de alimentos y no incluye líquidos que puedan ser drenados al alcantarillado. La basura también incluye latas, envases de vidrio, botellas, papel y cajas. Los materiales reciclables deben colocarse en los receptáculos adecuados según lo previsto.

Sección 2: Basura: La basura incluirá basura en el piso, botas y zapatos viejos, ropa desechada, cajas de cartón y todos los materiales de desecho que normalmente se recolectan de una casa o negocio. La basura debe colocarse en el bote de basura para que la recojan el lunes.

Sección 3: Escombros: Se entenderá por escombros las ramas de los árboles, la maleza, las hojas, etc.

Sección 3-A: Escombros: La ciudad recolectará electrodomésticos y muebles para el hogar. Con la excepción de cualquier electrónica. Ejemplo: televisores, computadoras, reproductores de DVD, microondas, etc. La ciudad tampoco recolectará ningún material de construcción, demolición o remodelación de ningún tipo. Incluyendo: alfombra, linóleo, lavabos e inodoros, gabinetes, tableros, madera contrachapada, alambre, maderas para paisajismo, cartón o cajas de cartón, llantas y baterías.

Sección 4: Será deber de toda persona que posea, administre, opere, alquile, ocupe cualquier vivienda, edificio u otro lugar donde se acumule o se produzca basura o desperdicios, proporcionar receptáculos para dicha basura o desperdicios colocados para su recolección por el servicio de basura. Se deben observar las siguientes reglas y regulaciones.

Sección 5: Los receptáculos residenciales serán proporcionados por el Pueblo, que se compran a Republic Services. Las tapas deberán mantenerse en los receptáculos en todo momento, excepto cuando se llenen o vacíen. Los receptáculos no deben tener más de 32 galones de capacidad cada uno ni menos de 20 galones de capacidad. Los propietarios deberán suministrar una cantidad suficiente de tales recipientes para contener la cantidad de basura o desperdicios acumulados. Todos los receptáculos, en todo momento, deberán estar contruidos y mantenidos de modo que estén cubiertos de modo que se impida la entrada de moscas. Se pueden usar botes de basura de plástico, pero los propietarios son responsables de la limpieza en caso de rotura de bolsas. La ciudad de Biscoe proporcionará un receptáculo por hogar. Si se necesita un receptáculo adicional, los ciudadanos pueden comunicarse con el Ayuntamiento al 428-4112 para solicitar un receptáculo adicional. El costo mensual se agregará a la factura de servicios públicos de cada mes.

Sección 6: Es deber de los propietarios u ocupantes colocar los contenedores al lado de la acera en los días designados para la recogida. Es responsabilidad del propietario o inquilino reemplazar cualquier receptáculo perdido o robado.

Sección 7: Será ilegal que cualquier persona queme cualquier materia en basureros o basureros o contenedores a granel. El municipio no recogerá ninguna materia líquida o semilíquida, ni deberá depositarse en contenedores para que los recoja el recolector de basura.

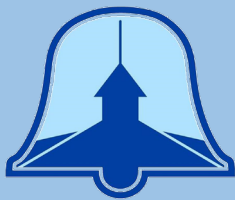
Sección 9: La recolección de escombros se realizará una vez a la semana, siempre que, sin embargo, en las semanas con ciertos feriados o cualquier emergencia en la ciudad que pueda ocurrir, no se proporcionará recolección.

Sección 10: Todas las ramas de árboles, troncos, etc., deben cortarse en longitudes no mayores de 6 pies y colocarse ordenadamente en una pila mirando en la misma dirección que la carretera y libres de todos los demás escombros y basura. Ninguna pieza que pese más de cincuenta (50) libras. La paja y las hojas de pino se recogerán cuando se coloquen en filas ordenadas junto a la acera, lejos de obstáculos como árboles, buzones de correo, letreros y bocas de incendio. Cada pila debe estar libre de ramas, basura y otros escombros. Si las hileras de hojas no cumplen con todos los requisitos, no se recolectarán.

Sección 11: Todas las grandes acumulaciones de desmontes de lotes, remoción de árboles o grandes cantidades de poda de árboles y ramas, construcción o reparación de edificios o viviendas deberán ser removidas por el contratista, propietario o individuo pagado.

Sección 12: Será ilegal que cualquier persona arroje, deposite, barra o rastrille en cualquier calle, acera o cuneta hojas, basura, mugre, desperdicios, vidrios rotos, latas, cáscaras de frutas, desperdicios, cenizas, papel desperdiciado o suelto. Dichos materiales se acumularán según se especifica en esta ordenanza y se colocarán en sus respectivos lugares o receptáculos adecuados según lo dispuesto en esta ordenanza.

Sección 13: Toda persona que viole las disposiciones de esta ordenanza será culpable de este delito menor y será sancionada con una multa que no exceda los ciento cincuenta dólares (\$ 150.00) o con prisión por un período que no exceda los treinta (30) días. Si tiene alguna pregunta sobre esta ordenanza o su aplicación, comuníquese con el Ayuntamiento.



USE SU SISTEMA DE ALCANTARILLADO CON PRUDENCIA

Podemos ayudar a prevenir la mayoría de los atascos y desbordes de alcantarillado con un programa de mantenimiento preventivo progresivo.

Los atascos y desbordamientos de las alcantarillas a menudo son causados por materiales inapropiados como grasas, aceites y grasas que son arrojados al sistema de alcantarillado. Las grasas, los aceites y la grasa son más livianos que el agua y tienden a acumularse en la parte superior y lateral de las tuberías de alcantarillado hasta que se produce un bloqueo.

Los sistemas de alcantarillado sanitario están diseñados para manejar tres cosas: agua usada, desechos del cuerpo humano y papel higiénico. A continuación se muestran algunas cosas sencillas para evitar bloqueos y ahorrar dinero.
