Public Hearing and Regular Session June 13, 2022

The Biscoe Town Board of Commissioners met in a regular session on Monday, June 13, 2022, at 7:00 pm in the Municipal Building.

Board Members Present: Mayor Eddie Reynolds, Commissioner Barry Jackson, Commissioner Jay Patel, Commissioner Asbill, and Commissioner Lynthacum. Mayor Pro-tem Kay Kinch absent.

Members of Management Present: Town Manager Brandon Holland, Town Clerk Laura Morton, Public Works Director Sam Stewart, and Police Chief Shane Armstrong.

Mayor Reynolds called the meeting to order.

Biscoe Town Board of Commissioners held a public hearing for the purpose of receiving public comments on the proposed Development Agreement and Purchase Agreement between the Town of Biscoe and Hubrich Biscoe, LLC on Town Owned Property & Possible Conveyance of Portion thereof (Montgomery County Tax Parcel ID#756816939475).

A motion was made by Commissioner Asbill, seconded by Commissioner Jackson, and so the motion carried unanimously to close the regular meeting and call to order the public hearing for the purpose of receiving public comments on the proposed Development Agreement and Purchase Agreement on Town Owned Property & Possible Conveyance of Portion thereof (Montgomery County Tax Parcel ID#756816939475).

The meeting was turned over to Rick Flowe with N-Focus who explained and went through the agreement. He said the agreement is 55%.

No one spoke.

Mayor Reynolds then opened the meeting to the Town Board for comments.

A motion as made by Commissioner Patel, seconded by Commissioner Asbill, and so the motion carried unanimously to close the public hearing and reconvene the special session.

Mayor Reynolds asked for discussion.

Commissioner Jackson asked when the reimbursement agreement changed from 50% to 55%? Manager Holland said at the last meeting the Board directed us to negotiated up to 60%. Commissioner Jackson asked if there was a dollar amount that equals the 5%? Manager Holland said I am not sure. Rick Flowe said we don't have actual construction cost. Commissioner Asbill asked if it was water and sewer. Rick Flowe said water and sewer, but most of the sewer is private sewer.

A motion as made by Commissioner Jackson, seconded by Commissioner Patel, and so the motion carried 3 to 1 to vote in favor of the Development and Purchase Agreements. (Voting No: Commissioner Lynthacum).

A motion was made by Commissioner Jackson, seconded by Commissioner Lynthacum, and so the motion carried unanimously to close the public hearing and reconvene the regular session.

The Pledge of Allegiance to the American Flag was recited and a moment of silence was observed.

Conflict of Interest Statement
