## TOWN OF BISCOE BOARD OF COMMISSIONERS MEETING May 11, 2020

The Biscoe Town Board of Commissioners met in a regular session on Monday, May 11, 2020 at 7:00 pm in the Municipal Building.

### Board Members Present:

Mayor Eddie Reynolds, Commissioner Gene Anderson, Commissioner Kay Kinch, Commissioner Dutch Anliker, Commissioner Lashaunda Ryan, and Commissioner Barry Jackson.

### Members of Management Present:

Town Manager Brandon Holland, Town Clerk Laura Morton, Public Works Director Sam Stewart and Police Chief Shane Armstrong.

### Call to Order/Moment of Silence/Pledge of Allegiance

Mayor Reynolds called the meeting to order at 7:00 pm. The Pledge of Allegiance to the American Flag was recited and a moment of silence was observed.

### **Conflict of Interest Statement**

Town of Biscoe Code of Ethics provides that public officials and employees be independent, impartial and responsible to the public; that governmental decisions and policy be made in proper channels of the governmental structure; that public office not be used for personal gain; and that the public have confidence in the integrity of its government. In recognition of these goals and in keeping with the ethical standards of conduct for town public officials and its employees, disclosure of interest in legislative action must be stated for the public record. The mayor or any member of the town council who has an interest in any official act or action before the council shall publicly disclose on the record of the council the nature and extent of such interest, and shall withdraw from any consideration of the matter if excused by the council pursuant to G.S. 160A-75.

#### **Public Comment**

The following spoke during public comment forum:

Mr. Charles Johnson of Hampshire Drive in Biscoe spoke during the public forum regarding a request received by the Town for a Sweepstakes business. Mr. Johnson said if he thought the sweepstakes business was legal he would open one himself. He said there is an influx of people from Texas, Georgia, and Ohio opening these type businesses. He said there is a small group of businesses called "Gift Surplus" businesses that have gone to court and are running their businesses the right way. He said if you allow one, others will follow. He said Sweepstakes businesses in Burlington and Lexington have been shut down. Mr. Johnson said Law Enforcements calls them casinos, we call them gambling establishments.

Mayor Reynolds asked what makes it illegal. Mr. Johnson said I am not saying it is illegal, but gambling is illegal in North Carolina. He said they typically start out with about 40 machines and increase from there. He said if they are allowed, this is a real possibility. Mr. Johnson said if they are found to be management wrong it is a Class G Felony. He encouraged the Board to talk to other Towns to educate themselves before a decision is made.

Commissioner Jackson asked what type of clientele these establishments attract. Mr. Johnson said they keep a lot of money on hand and there are a lot of robberies and killings. They have a bad image.

Commissioner Kinch asked what the difference in these types of businesses is (the ones Mr. Johnson has and these sweepstakes businesses). Mr. Johnson said ours have gone through the superior court system and have been approved. Commissioner Kinch asked which businesses have these type machines. Mr. Johnson named a few (Quik Chek, EZ Gas, and Quality Mart).

Commissioner Jackson asked how many machines could be placed in the Vanderveer building. Charles says up to 100. Commissioner Jackson asked if he was limited. Mr. Johnson said they are limited to 4.

Mayor Reynolds asked where the closest one to us is. Mr. Johnson said Moore County. Commissioner Ryan said there is one in Robbins. Mr. Johnson said if we are limited to 4 they should be limited to 4.

Mrs. Wendy Clegg of Johnson Street in Biscoe asked if there was any way to put something in the manhole to keep it from smelling. Public Works Director Sam Stewart said there is no way to stop it this time of year.



Mayor Reynolds asked if the Town was still going to have the drive in Bingo in June. Clerk Morton said we are planning on it but the time may need to be changed because 2 pm is the hottest part of the day.

Commissioner Anliker asked about schedule and opening back up. Manager Holland explained the Phases that NC Governor Roy Cooper had provided.



Commissioner Kinch said she had received a call regarding the use of Golf Carts in town. Mayor Reynolds said Chief Armstrong is looking into this and will be bringing information to us at the next meeting. Mayor Pro-tem Anderson said the request had come before the Board in the past but was not approved.

Mayor Reynolds asked Manager Holland if he had a Burger King update. Manager Holland said that Commissioner Anliker has information. Commissioner Anliker said he spoke with the realtor because of the high grass on the property. He learned that Burger King lost its funding because of the COVID-19 pandemic. He said it wasn't completely off the table. Commissioner Anliker said Wendy's is also interested.

Mayor Reynolds asked if the Town's code enforcement project was still on schedule. Manager Holland said yes. He continued by saying that the Town will soon need to hire contractors to clean up/tear down. He said the property owners will be billed. If not paid, there will be tax liens placed on the property as well as collecting the money through NC Debt Set-off.

Public Works Director/Fire Department Chief said the Fire Department would be glad to burn them when the Town gets to the point of removal. He said that will help with the cost.

There being no further business to bring before the Board, Commissioner Anliker, made the motion to adjourn, and Commissioner Jackson made the second. All voted in favor. Meeting adjourned at 7:30 pm
