

REQUEST FOR QUALIFICATIONS WATER ASSET INVENTORY AND ASSESSMENT ENGINEERING SERVICES TOWN OF BISCOE, NC

A. GENERAL

The Town of Biscoe issues this Request for Qualifications (RFQ) to secure engineering services in connection with the recently funded (AIA) Asset Inventory and Assessment Projects for the Town's drinking water system. The Town anticipates that this project will take approximately two years to complete.

B. SUBMISSION REQUIREMENTS

Please provide the following information in the RFQ response for engineering services:

- 1. Firm's legal name.
- 2. Location of offices, addresses, email and telephone number, the principal(s) of the firm and their experience and qualifications.
- 3. Water Experience. The specialized experience and technical competence of the staff to be assigned to the project with respect to water improvements, water system design, engineering, water system operation, or related work; description of firm's prior experience, including any similar projects; size of community served; names of local officials knowledgeable regarding the firm's performance on related work. Include at least three references within the past three years.
- 4. A proposed work plan which defines the approach to the work.
- 5. Hourly rates for personnel to be utilized on the project.

C. QUALIFICATION EVALUATION CRITERIA

The Town of Biscoe will utilize the following criteria in evaluating the responses received:

- Qualifications, Competence and Reputation of Firm and Personnel: Overall
 assessment of the firm's qualifications and reputation; Assessment of the
 ability and competence of the firm to conduct the work. Evaluation of the
 specialized experience and technical competence of the staff to be assigned to
 the project and the qualifications of those persons. Specific experience with
 respect to AIA- related work. Include at least three references within the past
 three years.
- 2. <u>Firm's Capability to Meet Time and Project Budget Requirements</u>: The capacity and capability of the firm to perform the work outlined, including any specialized services, within the period of the project.

- 3. <u>Related Experience on Similar Projects:</u> Assessment of the firm and assigned professionals in working with similar AIA projects.
- 4. <u>Recent and Current Work for the Town:</u> Evaluation of the Town's prior experience with this firm.

Summarized evaluation criteria and points assigned to each criteria are shown below:

D. SCOPE OF ENGINEERING SERVICES

The Town of Biscoe operates a water utility system that serves residential, business and industrial customers in the town. The Town was recently awarded an AIA grant and is awaiting the grant agreements for execution. The Town is working to identify a firm to assist with completion of the proposed scope of work related to these grants. In terms of timing, the projects will commence once a firm is selected, a scope of work established, and authorization is received from NCDEQ to begin work.

The proposed Asset Inventory and Assessment project will include at a minimum: review and assessment of all infrastructure assets, detailed review of critical assets, field inspections to support condition assessment, system maintenance assessment, and mapping of water system. Prepare maps addition to GIS layer on Town's existing GIS Map System. Development of a capital improvement plan, recommendations for funding, potential assistance in application submittals, together with specific system reviews to support needs to be negotiated with selected firm.
