

## NOTICE OF PUBLIC HEARING

### TOWN OF BISCOE

#### CLOSEOUT OF CDBG-INFRASTRUCTURE PROJECT #17-I-2955

Notice is hereby given that the Town of Biscoe will conduct a public hearing on Monday, August 8, 2022 at 7:00 pm, or as soon thereafter as the agenda will allow, at the Biscoe Town Hall located at 110 West Main Street, Biscoe, NC 27209 relative to the closeout of the Town's Community Development Block Grant 17-I-2955 for Infrastructure (CDBG-I). The original scope of work for the 17-I-2955 grant provided \$1,865,000 in CDBG-I funds (CDBG) to replace approximately 7500 Linear Feet of old (greater than 40 years old) deteriorated wastewater VCP collection lines and the replacement of the deteriorated Bruton Street Pump Station (greater than 40 years old). The lines that were targeted for replacement are on Bruton Street, Blake Street, Harris Street, Cagle Street, Baldwin Street and Hicks Street. The project not only replaced aging, deteriorated lines, but also eliminated inflow and infiltration from the collection and treatment system. The Town also received an amendment that included the replacement of an additional outfall line along Harris Street consisting of the replacement of 4 manholes, dig and replace of approximately 1,130 LF of gravity sewer, the reconnection of gravity sewer to 2 existing manholes and the reconnection of 1 sewer service. The overall LMI project benefit is 92.8% LMI.

The purpose of this public hearing is to review the expenditures and activities that have been accomplished through the Town's CDBG Infrastructure Grant (17-I-2955). All activities have been completed and the Town is in the process of closing out the grant. Total CDBG-I expenditures for the project are as follows:

Administration:	\$85,000.00
Preliminary Engineering Report:	\$13,500.00
Sewer:	\$1,743,300.09
